# RDA – Quick facts

---

- Content standard
  - Aligned with FRBR and FRAD conceptual models
  - Element set is compatible with MARC 21 element set
  - Independent of the format, medium or system used to store or communicate data
-

# MARC 21 – Quick facts

---

- Standard for the communication of data in encoded form
  - Element set is compatible with ISBD/AACR2 elements
  - Independent of the storage or display of data
  - Not tied to any one content standard
-

# Mapping MARC 21 to RDA

---

- Began in late 2006
  - Additions to RDA based on MARC 21 elements
    - Scale of graphic content (Field 507)
    - Date/Time and Place of an Event (Field 518)
    - Preferred citations (Field 524)

# RDA/MARC Working Group

---

- Formed in March 2008
  - Develop proposals for changes to the MARC 21 formats to accommodate RDA
  - Membership – LC, LAC, BL, DNB, OCLC, VTLS, ALA, JSC

# Working Principles

---

## □ MARC 21

- needs to maintain neutrality and flexibility concerning which types of records (authority, bibliographic, or holdings) map to which FRBR entities
  - needs to be neutral and flexible with respect to database designs that ingest MARC data
  - should support enterprise (internal) use of any of flat-file, linked authority and bibliographic and relational /object oriented database structures

# Working principles

---

## □ MARC 21

- Will support the granularity of RDA data ***following assessment of benefits for end-user and consideration of cost implications***

# Coded values

---

- ❑ Close compatibility between MARC and RDA vocabularies
  - ❑ Some extensions made to 007, 008 to accommodate RDA terms
  - ❑ Most RDA controlled vocabularies are open – if no corresponding code, encoded in variable field (e.g., 300 \$b)

  - \$o Start period
  - \$p End period
  - \$o Start period, \$p End period

# Changes to MARC 21 Authority

---

## RDA Element

- Place of birth
- Place of death
- Country assoc. with person
- Place of residence
- Place assoc. with corporate body
- Place assoc. with family
- Place of origin of the work

## New field – 621 Associated Place

- \$a Place of birth
  - \$b Place of death
  - \$c Associated country
  - \$e Place of residence /Location of headquarters
  - \$g Place of origin of work

# Changes to MARC 21 Authority

---

## □ RDA Element

- Address of person
- Address of corporate body
- Language of person
- Language of corporate body
- Field of activity
- Affiliation
- Occupation
- Gender
- Family information

## □ New fields

- 622 – Address
  - 622 – Address
  - 628 – Associated language
  - 623 – Field of activity
  - 624 – Affiliation
  - 625 – Occupation
  - 626 – Gender
  - 627 – Family information

# FRBR

---

- Identifying work, expression, and manifestation records in MARC 21
    - Extension of 2005 MARBI report
    - Proposed field 883 – Entity type
      - \$a – Terms: work, expression, manifestation, item
      - \$b – Primary entity type code: w,e,m,i
-

# FRBR

---

- Goal: to encourage experimentation
  - But ...
    - Considered confusing in current environment of linked bibliographic and authority records
    - Can identify FRBR entities via existing content designation
    - Today's experimentation will inform future direction
-

## Discussion papers – July 2009

---

- URIs for controlled values – MARC 21 (2709) or MARC XML?
  - Relationship designators
    - For Group 1 entities
    - For Group 2 entities
  - Enhancing 033 and 518 for Place and Date of Capture
  - Accommodating attributes for works and expressions
