

## **Issues between German and Austrian Libraries and OCLC Exchanging MARC 21 Data**

The issues outlined in the document received from the Consortium of Library Networks fall into several broad categories:

- Changes approved for the MARC 21 format and OCLC's schedule for implementing those changes, including factors that may affect implementation;
- The use of locally-defined fields in MARC 21 and issues related to sharing locally-defined fields in the context of WorldCat; and,
- Fundamental differences in cataloging practices that affect OCLC system's ability to recognize that records actually describe the same resource.

Each of these issues is a complex one with consequences for the processes associated with loading records into WorldCat and each needs more discussion in order to develop a common understanding. In the interim, OCLC has the following recommendations:

- In the short term, institutions that are already batchloading records to WorldCat should continue to use that method since Batchload processing has the data manipulation capabilities that are essential to efficient processing.
- In the medium term, we would propose to work with one of the partners to develop customized export tables that would better prepare data for processing through WCIRU.
- In the longer term, OCLC will enhance the WCIRU infrastructure to eliminate the need for the special export tables.

### **Issue 1: Recently Defined MARC 21 Elements**

The following MARC 21 elements were implemented by OCLC in August 2009:

- The newly defined subfield \$0, for the system control number of a related authority record, in a wide variety of MARC 21 fields
- The addition of subfield \$w to more fields
- Field 363, Normalized Date and Sequential Designation

These additions are documented in "Technical Bulletin 257: OCLC-MARC Format Update 2009" (<http://www.oclc.org/us/en/support/documentation/worldcat/tb/257/default.htm>). MARC Format changes are typically announced through a Technical Bulletin with other documentation being updated in the following months.

It would be useful to have some additional discussion about the inclusion of \$0 and \$w in records sent to OCLC to be sure that the record numbers that are included are numbers that would be useful outside the context of the system from which the record originated.

Confusion about these MARC 21 elements may have arisen because the document OCLC uses to track MARC elements which have and have not been implemented, “MARC 21 Bibliographic Data Elements Not Implemented by OCLC,” had not been revised until recently. A useful way of keeping up to date with OCLC Technical Bulletins is to subscribe to TECHBUL-L, which delivers announcements of newly issued Technical Bulletins and other OCLC documentation. Leader/19 coding for multi-volume and multi-part monographs has not yet been implemented because it requires the preparation and distribution of a new version of the Connexion client as well as major changes to OCLC’s internal record structure (since we store only those elements of the Leader that we use and Leader 19 has never been included). Without a new version of the client, this new coded element cannot be displayed to cataloging users and codes could not be protected from deletion.

### **Issue 2: Issues Based on Options and Matters of Common Practice**

**Multi-volume/multi-part monographs:** The philosophical differences between cataloging practices for multi-volume/multi-part resources in North American libraries and in libraries outside North America has long been a point of discussion point between OCLC and European libraries. The future implementation of the coding in Leader/19 will help ease that situation but the fundamental differences are likely to remain.

We would like to have a discussion of the various ways in which records for the parts or volumes are converted into MARC 21 records. As OCLC has loaded more and more records from German institutions, we have realized the variations (some subtle and some not so subtle) in how records are converted to MARC 21 pose difficulties in matching records so that holdings can be consolidated. Appendix A is a set of 8 examples. Each set contains from two to five records representing the same part or volume that have made their way into WorldCat because OCLC’s matching software was not able to identify them as representing the same item. A fuller understanding of these variations would help OCLC staff in improving the matching processes.

**Non-sorting characters:** The difference in practice between the use of a “non-filing” indicator in MARC 21 and the use of “non-sorting” characters (hex88 and hex89 in the MARC-8 character set) in other MARC formats is another issue with a long and tortured history. The use of the non-sorting characters in MARC 21 was approved in January 1999 but, up to this point, the coordinated effort required to implement the characters in the MARC 21 community has not happened, in large part because of the burden of legacy data and systems and the reluctance to maintain the two methods simultaneously.

For records that are batchloaded into WorldCat, there is an existing process that transforms the “non-sorting” characters into traditional MARC 21 non-filing indicators. The process works as follows:

1. When the non-sorting text is at the beginning of a field that has a defined non-filing indicator, the process deletes the non-sorting characters and calculates the correct value for the non-filing indicator.
2. If the non-sorting characters are in the middle of text, the characters are deleted.
3. If the non-sorting characters are at the beginning of a field or subfield that does not have a defined non-filing indicator (for example, at the beginning of the title subfield of a name/title added entry), the process deletes the non-sorting characters and the text enclosed in them.  
[We know that this part of the process is not ideal because, particularly in German, this produces text that is incorrect linguistically. However, it is in many ways the same as the requirement of AACR2 rule 25.2C1, which requires the deletion of initial articles from uniform titles.]

Currently, for records that come into WorldCat through WorldCat Interactive Record Update (WCIRU), this conversion of data is not available and the records would be rejected because the non-sorting characters are not considered valid characters. In the longer term, WCIRU should provide the same conversion to non-filing indicators that is done for batchloaded records. In the meantime, we would propose to work with one of the partners to build special export tables for use with WCIRU that would provide this conversion.

**ISBD punctuation:**

Previous discussions with the Deutsche Nationalbibliothek have helped OCLC staff understand the omission of ISBD punctuation when it duplicates the subfield coding. Only punctuation that is internal to the text of a subfield is input. The result of that discussion has been our agreement that the omission of ISBD punctuation is permitted in records sent to WorldCat. There was also a discussion paper at the MARBI meeting at ALA Midwinter 2010 that, if it returns as a proposal, would provide a way to code the record as representing this situation. Whether OCLC would develop software to insert punctuation either on record loading or for display has not been discussed.

**Issue 3: Handling Locally-(Regionally- or Nationally) defined Fields**

The paper lists a variety of fields that are properly designated as locally-defined by the use of a '9' in the tag or as a subfield code. Previous discussions with the DNB have reached agreement that most could be stripped in Batchload preprocessing or moved to other fields. The one problematic one is the use of the 029 for additional ISBNs related to the resource being cataloged. In this case, we have suggested an alternative field, field 776, to contain these related ISBNs. Manipulating the 029 is tricky since we sometimes care about numbers that we output in the 029.

Here also, the situation with records coming into WorldCat through WCIRU is different. With this method there is no ability to manipulate data and there is no flexibility in what fields can be stripped. In the longer term, WCIRU should provide the same flexibility in data manipulation that is done for

batchloaded records. In the meantime, we would propose to work with one of the partners to build special export tables for use with WCIRU that would provide this conversion.

#### **Issue 4: Varying OCLC Practices for Particular Data Elements**

First, we would like clarify that *Bibliographic Formats and Standards* is primarily designed to help to users of OCLC's Connexion interfaces in the creation and maintenance of bibliographic records. It is not intended to provide guidance for records created in other systems that are sent to OCLC for batchloading or through WCIRU.

##### **Position of the OCLC Number:**

For records batchloaded into WorldCat, OCLC follows the normal MARC 21 practice which places the control number associated with the system in which the record was created in the 001 field (with the 003 field contained appropriate identification of that system). If the incoming record contains an OCLC number (because, perhaps, the record originated in the OCLC environment), that number should be in field 035.

For records coming into WCIRU, the system ignores the content of the 001 field but expects to have the external system number in field 029. In the longer term, using a different method of conveying the external system number should be explored. In the meantime, we would propose to work with one of the partners to build special export tables for use with WCIRU that would provide this conversion.

##### **Implementation of 007 fields for "Kit," "Notated Music," "Text" and "Unspecified"**

For various reasons, OCLC has not implemented the "two-byte" 007 fields for use in bibliographic records (although they have been implemented for use in Local Holdings Records). The primary reason for not implementing is that these 007 fields do not provide any useful information beyond what is already coded in elements of the MARC 21 Leader and field 008 and would require users to provide redundant coding. OCLC's practice also matches that of the Library of Congress which does not include these 007 fields in its bibliographic records.

Implementing these also requires a new version of the Connexion client. In the longer term, OCLC should implement these four versions of field 007. In the short term, occurrences of these 007 fields can be removed from batchloaded records. Staff in OCLC's Leiden offices propose to provide special export tables for use with WCIRU that would provide this manipulation. In the meantime, we would propose to work with one of the partners to build special export tables for use with WCIRU that would provide this conversion.
